OS&H.001/21 WELCOME

The Chair welcomed members and Jeremy Day, Deputy Clerk to the Parish Council and his first meeting of this committee.

OS&H.002/21 TERMS OF REFERENCE OF THEOPEN SPACES AND HIGHWAYS COMMITTEE

The Deputy Clerk circulated the Terms of Reference of the Open Spaces and Highways committee. The Terms of Reference were received and agreed at the Full Council meeting held on 11th January 2021.

OS&H.007/21 MINUTES

RESOLVED that the Minutes of the Highways & Infrastructure meeting held on 18th November 2020 be agreed and signed by the Chair.

The committee received an update from the Traffic Monitoring group.

RESOLVED that the focus of the group remains on speeding across the Parish

RESOLVED that the Deputy Clerk arranges for a presentation from Thames Valley Police concerning the current enforcement policy in the Thames Valley area.

OS&H.009/21 STRATEGIC PLANNING

RESOLVED that a Strategic Planning Group be set up to make recommendations to the committee on strategic planning and direction for Open Spaces and Highways. Group will have no more than 5 members but other members of the committee will become involved as knowledge and expertise are required.

RESOLVED that the group will consist initially of Councillors Chris Jordan, Wendy Matthews, Ann Mayling, Kevin Brown and Carol Gibson.

RESOLVED that the Deputy Clerk will facilitate this working Group and work with the Chair to define Terms of Reference.

RESOLVED that the working group will report to each meeting of the committee and make recommendations regarding future strategic activities and projects.

OS&H.010/21 CONDITION REPORTING

The committee received a blank example of the report recommended by the Deputy Clerk to be presented to the committee in the future to update on the condition of the Parish in terms of Defects, Refurbishments and Improvements. Some

suggestions to enhance the report were give.

RESOLVED that the report be produced by the Deputy Clerk for review at each bi-monthly meeting and at the end of the month as an update between the meetings of this committee.

RESOLVED that relevant reports for the committee be distributed as received with an opportunity for members of the committee to address and questions to the Deputy Clerk.

The Deputy Clerk clarified that any play equipment, fitness equipment, associated signage and street furniture including bins and benches in any open space that is outside of a fenced play area becomes the responsibility of the Open Spaces and Highways committee. The Committee also received a report highlighting high risk issues and resolutions. The Deputy Clerk reported that he was going to take a detailed look at the condition of all equipment alongside the RoSPA reports within the committee's remit.

RESOLVED that the major risks should be addressed by the end of February.

RESOLVED that the Medium risks be identified by the March meeting of the committee with remedial action underway.
