Briefly describe the project / purpose for which you require a grant.

We have included a copy of our charitable purpose and aims which explain the overall purpose of our organization. We are fully insured and are submitting our application for charity status (CIO) this month.

This project is part of a range of activities planned for our first year.

The aim is to create a regular drop in session where anyone with school age children can pop in have a coffee, browse the pop up shop(if it is running that week) and have a chat. The purpose is to reduce social isolation and signpost to other agencies and groups as necessary. For example, we are a referral partner for The Baby Bank.

This is not a playgroup and we are ensuring we do not overlap with existing provision.

The group is child friendly but is primarily a venue for those adults raising children to meet and share experiences.

The meeting is free to all users and attendees will also be able to access the stock of pre-loved clothing and toys donated to us at the meetings. Although donations will be accepted there is no requirement for the attendee to contribute to access what they need.

We hope to fund the remainder of the items by donations in kind from local residents and businesses and already have commitments for most of the items.

We are talking to local schools about working together and hope to have a venue in Iver and Richings Park to hold the same style of meeting by September.

How will the project or activities benefit the residents of The Ivers?

Please include estimates of the number of Iver residents that will receive a direct benefit from the project or activities.

Many adults with school age children can find themselves isolated once their children are too old for the playgroup activities and in the last year many of the relationships that would have formed there have not been available. We expect to be able to reach a wide group for the pop up shop and drop in over the 2 hour session. Once we have built traction we would anticipate 20-25 attendees over the session. We will monitor numbers and use the outside space to put up a gazebo (with your permission) for the pop up shop if needed. This assumes no social distancing measures are in place.
