

## Reopening Project

As part of the Reopening Project, Buckinghamshire Council is encouraging local towns to animate their high streets. Street entertainers are a great way to improve the vibrancy of your town centre, encourage people to visit, help them have an enjoyable experience whilst shopping and promote repeat visits.

We are offering towns the chance to apply for up to £500 per town funding to help support you to book some street entertainment for your town between June and the end September 2021, be this a one off session or a repeat booking.

The deadline for making an application is **Monday 24 May**.

Applications must be made by the relevant Town or Parish Council.

It will be the responsibility of the town to undertake the booking directly with the provider and to ensure that all relevant Covid-19 Safe Guidance is followed.

Attached is a list of contact details for a number of suggested different entertainers we have collated. These are provided for information only and do not represent an endorsement by Buckinghamshire Council; you should ensure you undertake your own due diligence processes and quotations before confirming any bookings with entertainers. You can use these for your town or another provider of your own choosing – the use of local suppliers is encouraged where appropriate.

A higher priority will be given to those towns with markets or a larger number of shops or bigger High Street. We will also be looking at the best geographical spread when allocating funds to ensure the funds are evenly spread around the county.
