**NP.080/20 DECLARATIONS OF INTEREST**

**NP.082/20 MINUTES**

Cllr Gibson thanked Janet for her work with proofreading.

**NP.083/20 HERITAGE ASSETS**

Stephanie Bennett explained the reason for the exclusion of the press and public was because the discussion would include personal data.

The Press and Public were excluded as personal data was being shared and discussed at the meeting.

Stephanie Bennett and Leigh Tugwood left the meeting at 17.05pm.

Cllr Gibson explained the purpose of the Heritage Asset Schedule was to protect the town and streetscapes and, where possible, to achieve consistency in any future development or redevelopment.

A general discussion about the purpose of the Heritage Asset Schedule took place.

Cllr Mayling reported that O'Neill Homer had advised not to include properties in Pinewood Green in the Heritage Asset Schedule. This is to be reviewed to retain consistency with Chiltern & South Bucks Adopted Townscape Character Report.

**Resolved** to communicate the importance and reasons for having a Heritage Asset Schedule to residents.

**Resolved** that Cllr Mayling draft a factual summary of Neighbourhood Plan responses for communication to residents.

**Factual inaccuracy noted:** No detached dwellings in The Ridings.

**Resolved** to incorporate points, raised by landowners, in the Neighbourhood Plan.

**Resolved** that Cllr Gibson circulates Janet's proofread version of the Neighbourhood Plan.

**Resolved** no changes to policy IV5 are necessary, other than the factual inaccuracies that have been identified in Appendix C.

**Resolved** to apply the Heritage Listing decision consistently to all heritage properties identified in the Draft Neighbourhood Plan.

**Resolved** Cllr Gibson to identify Croft Cottages, brick workers cottages, (off Bangors Road South) and consider their inclusion on the Heritage Asset Schedule.
