

## IVER RECREATION GROUND FENCING (INCLUDING ALLOTMENT FENCING)

*Appendix 9*

In August 2022, Boundary Fencing (formerly Secure-A-Field, a regular contractor of TIPC) completed some essential maintenance work replacing two small sections of fencing on the Iver Recreation Ground that border the Iver Allotment Site. This was following a survey carried out by the Deputy Clerk and the Business Administrator.

At the same time, a further review of an area at the far-left hand corner of the Recreation Ground was reviewed and also the corner of the Allotment Site that provides 'un-official' access to the Recreation Ground via the allotment site from Dutton Way.

Far left side of the Iver Recreation Ground

This is an unofficial pathway that is a dead end and is often frequented by children / young adults. This is a wooded area and is quite possibly an opportunity for fly tipping – the Grounds Team has cleared away significant amounts of litter from this area on a regular basis. The suggestion here is that there is gated access so that the Grounds Team / Contractors can access for maintenance purposes.

Un-official access to Iver Allotment site from Dutton Way

There is no automatic right of way from this location although, before the main entrance gate to the Allotment site was padlocked, residents used this as a 'cut through' to the Recreation Ground. We have received feedback from Allotment holders that people are still attempting to cut through despite the locked gate at the other end. There are reports of people (non Allotment holders) also using the back entrance to acquire water from the allotment water

supply. The Grounds Team have recently cleared a fly tip from just inside this entrance that was probably tipped by accessing this the Allotment site here.

**The meeting is asked to consider both of these fencing requirements and to give the Deputy Clerk some direction in progressing these matters, considering the indicative quote received from our regular fencing contractor.**
